Principles and Policy Items

- A proposal was made to amend the Enrollment Policies and Procedures to allow more online options for completing the application as a result of Covid-19.

- The motion passed unanimously.

- The Board was updated on enrollment. 182 seats have been offered and 154 have fully turned in their paperwork. If any paperwork is not completed by the deadline, the registrar will then proceed to offer seats to those on the waitlist.
- The Early Academy is not offering classes for April, May, and June, due to Covid-19, and a proposal was made to suspend the Early Academy's rent and loan payments for these three months due to the unforeseen difficulty presented by Covid-19. Payments would resume in July.
- Bob White, seconded by Jamie Grant, made a motion to approve.
- The motion passed unanimously.
- The Board was updated on the Best and Brightest bonus and that 36 teachers were eligible and three were eligible for a recruitment bonus. The school is waiting for notification from the district on the amount.

Monitoring and Reporting Items

- The variance reports for February and March were reviewed.
- Financial statements for the period of February and March were reviewed. Budget-to-actual for the same period was also reviewed.
- Variances remain minimal and cash-on-hand projections continue ahead of pace for the end of the year.
- A draft of a proposed budget for 2020-2021 will be discussed at the next meeting.
